1. PURPOSE OF REPORT

- 1.1 To present the council's Young People's Strategy which details the work the council will undertake in relation to young people aged 11 to 19 years old and up to 25 years old for those who are disabled or have special individual needs.

2. RECOMMENDATION

- 2.1.1 Supports and acknowledges the work to be carried out across the council in relation to young people.
- 2.1.2 Approves the Young People's Strategy (detailed in appendix 1).

3. BACKGROUND TO THE REPORT

- 3.1 The contribution that Borough and District Councils can make to positive outcomes for young people is increasingly being recognised. The understanding of, and connections to, the local community makes District/Borough Councils perfectly placed to deliver some key areas of work for young people.
- 3.2 The attached strategy sets out the work the authority will do to support young people in the borough to meet their full potential.
- 3.3 This strategy is aimed at young people aged 11 to 19 years old and up to 25 years old for those who are disabled or have special individual needs.
- 3.4 This strategy has been put together via consultation and discussion with young people. Young people were consulted in the initial stages to ensure their views were

used in the formulation of a draft strategy and they have then been consulted on the final draft strategy.

3.5 Middle managers have been consulted on the work currently being undertaken in relation to young people by the council and these areas of work have been taken into account when formulating the strategy, in order that these areas can be showcased and evidenced via this strategy.

3.6 The Young People's Strategy sets out the work the council will undertake under 5 key themes:

- Employment
- Empowerment
- Enjoy life
- Health and well-being
- Safety

3.7 The aims and objectives of the Young Person's Strategy will be achieved by joint working with our partners and communities and links with a number of other key delivery partnerships, including:

- Hinckley and Bosworth Health and Wellbeing Partnership
- Hinckley and Bosworth and Blaby Community Safety Partnership
- Hinckley and Bosworth Think Family Partnership
- Hinckley and Bosworth Employment and Skills Partnership

3.8 Monitoring of the Young People's Strategy will take place via an annual review of progress against the key aims and objectives. This annual review will evidence work delivered and show the impact of the work on young people. The Strategy will be refreshed annually at the Hinckley and Bosworth Young People's Conference.
