Parish and Hinckley Community Initiative Fund Allocation of Grants 2023/24

Report of Director of (Corporate Services)

1. Purpose of report

1.1 To request that the Scrutiny Commission endorses the allocation of the Parish and Community Initiative Fund and Hinckley Community Initiative Fund 2024/25.

2. Recommendation

- 2.1 That the scrutiny Commission endorses the funding allocations of £91,892 for the schemes as detailed in section 3.3.
- 2.2 That the Scrutiny Commission supports allowing 7 previous years schemes totaling £11,374.60 to be completed and continue to be funded as detailed in section 3.4

3. Background to the report

- 3.1 Since 2005 the Parish Community Initiative Fund and Hinckley Community Initiative Fund have distributed £1,830,950 towards 456 local parishes or voluntary organisation schemes.
- 3.2 In 2023/24 the scheme received 35 applications from across the Borough and a total of £90,383 was awarded to 21 schemes.
- 3.3 Applications for 2024/25:

The assessment panel then determined which applications they felt should be awarded grant funding. This panel consisted of Caroline Roffey Head of Street Scene Services, Ian Pinfold – Green Space Manager, Amie Carroll – Senior Anti-Social Behaviour Officer, Paul Scragg – Senior Green Space Officer, Gary Upton- Housing Repairs Manager, Graham Chilvers – Health and Recreation Manager, Danielle Leggett – Climate Reduction and Climate Change Officer, Paul Grundy – Senior Planning Officer (Conservation and GIS)

The grant will fund a maximum of 50% of the project costs. Each applicant must seek support from their Parish Council and Borough Councillor. Only capital items over £5,000 in value are funded and the lowest submitted quote has been used to calculate the maximum eligible grant, unless a good reason has been provided for using a higher quote. Each application has been scored individually against the criteria by 2 officers and an average score given.

To reflect the scale and cost of some climate change projects, it was agreed after a review in 2023 that the maximum grant award will be increased to $\pounds 20,000 / 50\%$ of project costs. This increased grant size would overrule the $\pounds 12,000$ per parish limit and would only be applied for significant carbon reduction projects.

13 applications have been received requesting a total of £102, 610.

Based on the information in Appendix 1 the assessment panel recommends funding the following schemes totalling £91,892. This includes £4,225 for HCIF schemes. (Applications are set out in alphabetical order by parish and parish name is given in brackets).

- 1. Community Outdoor Gym Barwell Parish Council (Barwell). Outline: The installation of 8 x items of outdoor gym equipment at Barwell Park. £4,797.
- Chapel House Restoration and preservation Projects Market Bosworth Free Church (Market Bosworth) Outline: The installation of damp proofing, the eradication of woodworm and redecoration of the Chapel House for use as a community building. £3,692.
- 3. Replacement Aerator Market Bosworth Bowling Club (Market Bosworth) Outline: The purchase of a new aerator to ensure quality maintenance of the greens. £3,823.
- Swimming Pool Filtration System Upgrade Bosworth Academy Trust (Desford)

Outline: The replacement of the swimming pool filter for the school and community swimming pool. £10,047

- Project Net Zero Sport in Desford (Desford) Outline: The installation of air source heat pumps and solar panels at the sport in Desford facility. £20,000
- Improvement works at Hurst Road Play Area Earl Shilton Town Council (Earl Shilton).
 Outline: The installation of new items of play equipment at the play area. £2,554
- Baptist Church landscaping scheme LBC Earl Shilton (Earl Shilton) Outline: Landscaping in outside area at Earl Shilton Baptist Church. £9,446
- Trinity Community Church Youth and Children's Room Trinity Community Church (Hinckley Castle)
 Outline: 4 x new windows and the refurbishment of the children's and youth space at Trinity Community Church, Wesley House. £4,225 *
- Church Meadow Power Supply Nailstone Parish Council (Nailstone) Outline: The installation of a mains electricity supply to Church Meadow in Nailstone to facilitate further community events that require a power supply. £5,552
- 10. Solar Panels Sheepy Memorial Committee (Sheepy) Outline: The installation of solar panels at sheepy Village Hall. £3,759
- 11.Car park Extension Stoke Golding Parish Council (Stoke Golding) Outline: The extension of the car park at Hall Drive recreation ground for park users and for users of the village hall. £9,332
- 12. Disabled WC/Shower Facility Without Walls Church (Stanton-under-Bardon) Outline: The installation of a new disabled WC and shower facility within the church building. £8,875.
- Improvements to Community Area DCC Orton-on-the-Hill (Twycross) Outline: Repairs to the porch area of the church building and the reconfiguration of the internal area to create a community function area. £5,790.

*Hinckley CIF schemes funded from Special Expenses total £4,225

3.4 Previous Years' Applications

There are 5 applications totalling \pounds 8,799 which were approved in 2022 and 2023 where the projects have been delayed. These projects will be completed in 2024/25. The projects are:

 Mobile Vehicle Activated Signs – Peckleton Parish Council (Peckleton) Outline: The installation of a mobile vehicle activated sign in Kirkby Mallory. £2,000.

- Information boards and heritage signs Peckleton parish Council (Peckleton) Outline: The installation of information boards telling the history of Kirkby Mallory. £673.
- New internal porch St Margaret's Church (Stoke Golding) Outline: The installation of an oak framed double glazed interior porch. £5,358.
- Shenton lighting Sutton Cheney Parish Council (Sutton Cheney) Outline: The conversion of 4 heritage lights in Shenton to more energy efficient LED lanterns. £558.
- Enhanced Planting around the Village Sutton Cheney Parish Council (Sutton Cheney)
 Outline: Planting around the 4 gateway areas across the village of Sutton Cheney. £210.

A further 2 further projects totalling £2,575.60 - Streetlight improvement schemes at Sutton Cheney and Peckleton have been completed, however the applicants have agreed to pay the contractor over a 5 year period. It has therefore been agreed that these grants will also be paid over a 5 year period on receipt of an invoice from the contractor. Outstanding amounts for these 2 applications are Sutton Cheney £1,339.60 and Peckleton £1,236.

5. Financial implications (IB)

- 5.1 The allocation of £91,892 for 2024/25 will be funded from £134,000 set aside in the capital programme which includes £10,000 for HCIF schemes.
- 5.2 For 2023/24 schemes, £11,374.60 will be carried forward to fund the delayed projects.
