Mallory Park Race Circuit – Principles Fundamental to Statutory Notice 2015

A) Definitions

<u>High Noise Day</u> - A day when the noise level from circuit activities at the designated monitoring location does not exceed 68dBLAeq(30), unless for a special parade day by written agreement with HBBC. Two parade day requests per annum are anticipated and shall include a noise management plan for the event.

<u>Medium Noise Day</u> - A day when the noise level from circuit activities at the designated monitoring location does not exceed 55dBLAeq(30min)

<u>Non-Noise Event Day</u> - A day when the noise level from circuit activities at the designated monitoring location does not exceed 45dBLAeq(30min)

<u>Quiet Day</u> - A day when the noise level from circuit activities at the designated monitoring location does not exceed 38dBLAeq(30)

B) Overriding Conditions:

- i. There must be a minimum of two Quiet Days per week (see 'exception' in vibelow)
- ii. There must be at least one Quiet Weekend per month and a Quiet Weekend must follow a two day High Noise weekend.
- iii. There may be an unlimited number of Non-Noise Event Days excepting that the quiet day provisions given above must be respected.
- iv. In no circumstances will there be three consecutive days of High/Medium Noise or combination thereof.
- v. There will be no drifting or motocross as defined by the ACU
- vi. 'Corporate Event Weeks' (5 consecutive days of 'non-noise') may replace High or Medium Noise days in any one week; those High/Medium Noise days to be forfeit in such cases.

C) In-season - from 1st March to 31st October (in which there are 8 months / 35 weeks)

Weekends

- i. 8 x two day High Noise weekends (one per month)
- ii. 19 x single High Noise Weekend Days, which may be held on Saturday or Sunday.

Weekdays

- *i.* 32 x High Noise weekdays (one per week) but may not be used on the Friday before a two-day High Noise weekend ... this would normally be the Wednesday test day
- ii. 32 x Medium Noise Days (one per week) Medium noise days could be used any day but may not be used on the Friday before a two day High Noise weekend.
- iii. One High Noise Weekday in any week may be substituted for one of the five consecutive Non-Noise Event Days to allow corporate vehicle launches.

<u>D) Out of season - 31st October to 1st March (in which there are 4 months / 17 weeks)</u>

- i. A maximum of five (5) High Noise Days may be used at any time but there may be no consecutive High Noise Days.
- ii. A maximum of eight (8) Medium Noise Days may be used at any time but there may be no consecutive Medium Noise Days.

Summary of Permitted Activity

High and Medium Noise days (in total) – 112

Of which:

High Noise days at weekends - 35 (in season - of which 16 will be part of 2-day

events -8 weekends)

- 5 (out of season)

Fully Quiet Weekends - 8 (in season)

Weekday High Noise Days - 64 (in season)

- 8 (out of season)

Other controls relating to hours and individual vehicle control will remain as per previous draft notice.

Trackside levels shall be established following installation of barriers and levels agreed to achieve the current control levels.

Additional Control

Appropriate measures will be introduced to limit the noise effect from any public address system, as experienced in the village
