WHEELED BIN AND CONTAINER POLICY

Report of Director (Environment and Planning)

- 1. <u>PURPOSE OF REPORT</u>
- 1.1 To seek Member's approval for proposed minor amendments to the Council's Wheeled Bin and Container Policy.
- 2. <u>RECOMMENDATION</u>
- 2.1 That Members approve the revised Wheeled Bin and Container Policy attached at appendix 1 incorporating the amendments detailed at 3.4 of this report.
- 3. BACKGROUND TO THE REPORT
- 3.1 The Council first introduced wheeled bins in 2004 to facilitate efficient storage and collection of household waste. In April 2012, a new dry-recycling wheeled bin service was introduced replacing the bag and box collection system to make it easier for residents to recycle and help the Council achieve its recycling targets.
- 3.2 The Council currently has a contract until 1/4/18 with Palm Recycling to collect, retain and recycle kerbside dry recycling materials. Executive agreed that on expiry of this contract the Council would bring the dry-recycling service in-house following an independent value for money review of the service options available taking into account:
 - 1. the removal of dry-recycling credit payments by the Disposal Authority; and 2. current recycling market conditions.
- 3.4 It was agreed that a comingled dry-recycling service would be operated in-house from 2 April 2018 whereby all materials currently collected are placed in the bin (replacing the existing dual-stream service which requires the use of an inner caddy inside the bin to store paper and cardboard). The materials collected will remain unchanged but will be reviewed in accordance with recycling market changes. Currently black plastic and film will not be collected as is the current position. Whilst reviewing the policy, the opportunity has been taken to provide additional minor

clarifications/changes where necessary. The main changes made to the policy are summarised below:

- Confirmation that a comingled dry-recycling service will be introduced from 1 April 2018

- Removal of reference to the internal caddy and confirmation paper/card to be stored with other materials inside the bin

- Revised wording for dealing with bins left on the public highway under the section 46 procedure.

- Additional details added under "Assisted Collection" service noting a bag and box service will be provided where it is not safe to provide a wheeled bin service
