 - (b) the tenant is a body in which I or a relevant person has a beneficial interest

7. Any beneficial interest in securities of a body where:
- (a) that body has a place of business or land in the Council's area; and
 - (b) either:
 - (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
 - (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class

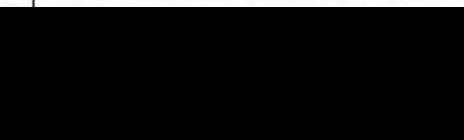
SENSITIVE INFORMATION
