- 2. The Council's budget requirement as set out in report C48 to Council on 31st January 2006, including Special Expenses, be £9,952,153;

- 3. The Council's budget requirement including Special Expenses and Parish Councils be £11,070,679;
- 4. The contribution from Revenue Support Grant and Non Domestic Rates be £6,387,000;
- 5. In accordance with Council Policy, the Collection Fund Surplus estimated at £24,488, be transferred to the Pension Reserve;
- 6. The Council Tax for Borough wide services, excluding Special Expenses and Parish Council precepts, for Band D be £79.82;
- 7. The Council Tax for Borough wide services and an average of Special Expenses Services for Band D be £99.11;
