#### 272 REVIEW OF FEES AND CHARGES 2005/06 (SEAC2)

The Committee's views were sought on the proposed fees and charges to be applied in 2005/06 in respect of parks, open spaces and cemeteries, particularly insofar as they related to the Special Expenses area.

  - (b) in respect of cemeteries

## 274 SANDY WALK, HINCKLEY

Following questions raised by Members, the Leisure Services Manager reported that it was understood that the maintenance of this footpath was the responsibility of the Leicestershire County Council, as highway authority, much of which was contracted out to Groundcare. There was uncertainty, however, as to the obligation of adjoining landowners and the actual extent of this footpath. It was, therefore, proposed by Mr. Thorpe, seconded by Mr. Hinton, and

<u>RESOLVED</u> - a report be submitted to the next meeting of this Committee identifying areas of responsibility for maintenance of this footpath and details of any agreements with the Borough Council.
