210 MINUTES (SEAC3)

211 SPECIAL EXPENSES AREA BUDGETS 2006/07 (SEAC4)

Prior to consideration of this item circulated to Members were pages 4 of 5 of Appendix 1 to the report of the Head of Finance and ICT.

Further to minute number 53 of 8th June 2005 the Committee was informed that no suggested budget growth items had been received by officers by the 10th August 2005 deadline.

Mr. Stanley left the meeting at 6.53 p.m.

Reference was made to the recently-produced Green Space Strategy and concerns expressed that no play facilities were available in De Montfort ward and on the motion of Mrs. Wright, seconded by Mr. Davis it was

<u>RESOLVED</u> – Cabinet and Council be requested to give consideration to the budget for the Special Expenses Area for 2006/07 being increased to provide much-needed play provision in the Swallows Green area.

212 SPECIAL EXPENSES AREA BUDGET MONITORING (SEAC5)

Again Members considered the budgets and spending to date for the Special Expenses Area. Concerns were expressed as to the current situation at Ashby Road Cemetery, Hinckley whereby in some instances scaffolding had been erected to support headstones. Discussion ensued regarding the national standards which applied and possible insurance provision and the suggestion made that staff within the cemeteries section investigate the cost if remedial work to the tombstones was undertaken by the Council.

On the motion of Mr. Thorpe, seconded by Mr. Davis it was

<u>RESOLVED</u> – a report be produced for the next meeting showing the extent of the memorial problems at Ashby Road Cemetery and the likely repair costs.

213 ESTABLISHMENT OF A PARISH COUNCIL FOR BARWELL (SEAC6)
