184 TOWN & COUNTRY PLANNING ACT 1990 - APPLICATIONS TO BE DETERMINED

A schedule of planning applications was presented to members and considered as follows:

(a) 13/00579/HOU – Extensions and alterations to dwelling, 49 Stamford Drive, Groby – Mr S Dempsey

It was noted that this item had been withdrawn from the agenda.

(b) 13/00658/COU - Change of use of land to holiday park and siting of 4 static caravans (part retrospective), The Oaks, Stapleton Lane, Kirkby Mallory - Mr G Penney
