## 225 21/00664/FUL - CROWN FARM BAGWORTH ROAD NAILSTONE

Application for proposed change of use from agricultural to storage and distribution.

The agent spoke on this application.

Whilst generally in support of the application, some members were concerned about future intensification of use of the site. It was moved by Councillor Bray and seconded by Councillor Findlay that permission be granted with a condition restricting permitted development rights in relation to the industrial units. Upon being put to the vote the motion was CARRIED and it was

  - a. The completion within three months of the resolution of a S106 agreement to secure off-site landscaping in accordance with drawing 21.1568.001 rev B;

- (ii) The Director (Environment & Planning) be granted powers to determine the final detail of planning conditions;
- (iii) The Director (Environment & Planning) be granted powers to determine the final terms of the S106 agreement including trigger points.

#### 226 21/00523/HOU - 53 CHURCH LANE, RATBY, LEICESTER

Application for single storey extension to the front and rear of the property including demolition of existing porch and chimney breast and relocation of main entrance to side of property.

## 227 21/00540/FUL - LAND TO THE REAR, OF 59 HIGH STREET, BARWELL

Application for demolition of existing workshops and stores and construction of new medical centre with associated parking and landscaping.

The applicant spoke on this application.

Notwithstanding the officer's recommendation that permission be refused, members felt that the facility was needed in the area and were disappointed with the recommendation of the highways authority that permission be refused. It was moved by Councillor Cope and seconded by Councillor Bray that permission be granted as the need for the facility outweighed the highway safety issues based on evidence of lack of incidents. Upon being put to the vote, the motion was CARRIED and it was
