# PLANNING COMMITTEE – 20 November 2012

### Re: THE BOROUGH OF HINCKLEY AND BOSWORTH ( LAND AT THE DOCTORS SURGEY, BACK LANE, MARKET BOSWORTH) TREE PRESERVATION ORDER 2012

#### Wards Affected: Market Bosworth

#### 1. <u>PURPOSE OF REPORT</u>

For members to consider the confirmation of the above Order

### 2. <u>RECOMMENDATION</u>

That the Order be confirmed as made, without variation.

## 3. BACKGROUND TO THE REPORT

The Borough Council has the power to make Tree Preservation Orders Under Section 198 and 201 of the Town and Country Planning Act 1990. The above Order was made under delegated powers on 21 of June 2012. A copy of the order is attached to this report. The effect of the Order is to protect the tree set out in the attached schedule and plan, indicated as T1 – Black Alder (Alnus Glutinosa).

The Order came into effect when it was made and remains in force until approved, withdrawn of for a maximum period of 6 months from making. The reasons for making the Order are that the tree contributes to the visual amenity of the area as the species of Alder is an unusual variety, the tree helps reduce the harsh appearance of the building and the tree stands in good health with an appropriate remaining life span. A Tempo Assessment (Tree Evaluation Method for Tree Preservations Orders) has been used to evaluate this tree and the outcome has identified that this tree is "TPO Defensible" (TPO Defensible is a status which means that the tree is worthy of protection with a Tree Preservation Order). A copy of the completed tempo assessment is attached to this report.

The Council has received nine letters of objections in respect of this Tree Preservation Order. Some issues raised within the letters referred to parking provision at the Surgery. Under a recent application the tree was proposed to be removed to provide further off street parking at the site. During the course of the application, owing to the nature of the tree, the application was amended to a scheme which retained the tree and provided less parking. It is important to note that the matter of parking provision is not an issue to be considered for the confirmation of this Tree Preservation Order.

In addition to concerns regarding parking at the surgery the following points were also raised within the letters of objection received:

- a) It is not an endangered tree.
- b) It is covered by Ivy which is a parasite.
- c) The condition of the tree is appalling.
- d) The tree should be assessed by reference to its size, form, potential as an amenity and that a reasonable degree of public benefit would accrue.
- e) That the tree is of low quality Category C in terms of Trees and Development and should not be a constraint on development with reference to Appendix 1 Table BS5837.

In response to each point of objection, the Council's Tree Officer submits the following comments in support of the recommendation to confirm the Order:-

- a) A tree does not have to be an endangered species in order to merit protection by TPO.
- b) Ivy is not a parasite. It only uses a tree for support and can be removed without damage being cause. In this instance the Ivy should be removed from the tree.
- c) The applicant's own arboricultural assessment describes the tree as "of an age and condition as to make a reasonable contribution to the public visual amenity of the locality for at least another 10 to 20 years". No pests, diseases or disorders have been identified.
- d) A TEMPO assessment (Tree Evaluation Method for Tree Preservations Orders) takes these aspects into account. A TEMPO assessment scores 13 -TPO Defensible.
- e) This refers to an out of date 2005 British Standard. The current standard - BS5837:2012 "Trees in relation to design, demolition and construction" makes no reference to Category C trees in this way.

The Order is already in effect and will be effective until 21 November 2012. If the TPO is not confirmed on or before this date then the protection will lapse. If it is confirmed then the tree will be protected indefinitely. This means that anyone wishing to carry out any works to the tree will have to make an application to the Council following the statutory procedure. This includes the landowner who remains responsible for the maintenance of the tree. Anyone can, however, apply for consent from the Council to do works to the tree, in particular if they wish to carry out works on trees which overlook their own land. The only time consent of the Council is not required is if a particular tree within a TPO is dead, or dangerous, but the person proposing the works must first show that the tree is in fact dead, or dangerous. In addition, the Council would require 5 days notice prior to any works being done under this exemption.

Owing to the prominence of the tree, its healthy condition and the amenity value it brings to the area, all as outlined above, it is recommended that the Order be confirmed.
