Community Governance Review – draft recommendations

Report of the Chief Executive

1. Purpose of report

1.1 To present the final recommendations in respect of the community governance review.

2. Recommendation

- 2.1 The recommendations contained in paragraphs 3.8.1 to 3.8.4 be approved.
- 2.2 The Director (Corporate and Street Scene Services) be authorised to make the necessary Orders for change.

3. Background to the report

- 3.1 In accordance with the Local Government and Public Involvement in Health Act 2007, each local authority is required to periodically undertake a community governance review of its local authority area. This is an exercise where the parish electoral arrangements across the whole area are reviewed to ensure that they are appropriate and relevant.
- 3.2 The council is undertaking a review at this time because a period of ten years has elapsed since the last review in 2012. This is in line with government guidance that it is good practice to conduct a review every 10-15 years.
- 3.3 Furthermore, the Local Government Boundary Commission for England (LGBCE) has requested an electoral review of the ward boundaries which is provisionally scheduled to commence in 2026. They advise that a community governance review is undertaken prior to an electoral review.

- 3.4 Council approved the terms of reference for the review at its meeting on 22 February 2022. There was then a period of public consultation from 23 February to 18 May 2022.
- 3.5 Consultation was undertaken in a variety of ways. These are outlined in paragraphs 2.1 to 2.2 of appendix A.
- 3.6 The Community Governance Review Working Group considered the responses and made draft recommendations which were approved for further consultation by Council on 12 July 2022.
- 3.7 Consultation on the draft recommendations took place from 13 July to 7 September 2022. More detail about this consultation can be found in paragraphs 2.3 and 2.4 of appendix A.
- 3.8 The Community Governance Review Working Group met on 29 September to consider the responses to the consultation on the draft recommendations. The working group agreed the following final recommendations. Please note that only those areas where change is recommended are listed below. See section 7 of appendix A for detailed consideration of each parish.
