Report of Director (Corporate and Street scene Services)

1. Purpose of report

1.1 To seek Council's approval to adopt and implement the Green Space Strategy & Delivery Plan 2023 - 33.

2. Recommendation

- 2.1 That Council adopt the Green Space Strategy and Delivery Plan.
- 2.2 Members agree the capital investment and budget requirements for schemes over the term of the plan, as detailed in section 5.
- 2.3 That Council delegate delivery of the Strategy and Delivery Plan to the Head of Street Scene Services and Executive Member for Parks, Open Spaces and Neighbourhood Services.

3. Background to the report

3.1 This Green Space Strategy (Appendix 1) and Green Space Delivery Plan (Appendix 2) seeks to build on the improvements delivered by Green Space Delivery Plan 2014 - 18 and determines the priorities for improvements to HBBC-owned green spaces for the next ten years. They are underpinned by a Technical Supporting Document (Appendix 3).

Through this strategy, the Council, working in conjunction with key green space partners and stakeholders, will work towards meeting the following vision statement. "To enhance and enrich the lives of our residents and visitors to the Borough via the delivery of quality green space through partnership engagement with our communities".

The Key Themes

For this vision to be achieved, it is important that there are set of guiding themes underpinning the Strategy and as such 4 themes have been identified.

- Protect, increase, maintain and celebrate our green spaces
 Increase biodiversity and reduce environmental impact
- 2. Increase biodiversity and reduce environmental in
- Increase and improve green infrastructure
 Encourage active and healthy lifestyles

Influencing Factors

Within each of these four themes, this strategy identifies key actions that need to be addressed, taking due regard of relevant strategies at national and local levels.

3.2 Key capital projects and improvements listed within the Delivery Plan may change depending upon the resources available. The plan will be updated annually to reflect the funding available, and to deliver the non-capital priorities within the plan. Dependent on the Council's financial position projects will only proceed if there are sufficient s106 receipts, external funding, or internal finance.

Should funding not be available through s106 receipts then these shortfalls will be considered on a project-by-project basis through the annual budget setting process.

4. Exemptions in accordance with the Access to Information procedure rules

4.1 This report can be heard in public session.

5. Financial implications IB

5.1 The estimated costs are summarised in the table below. Budgets will require Council approval in line with financial procedure rules. Schemes will only take place when relevant funding has been secured.

5.2 Growth bids will be requested for the forthcoming years as part of the budgeting setting process for bids where funding is either secured or is in the process of being secured.

6. Legal implications MR

6.1 The law in relation to parks and open spaces is contained in a number of statutory provisions extending over many years beginning with the Public Health Act 1875 as amended, allowed the purchase, lay out, plant improvement and maintenance of land for use as public walks and pleasure grounds. The Open Spaces Act 1906 defined open space and contained provisions for open spaces to be transferred to the Council's management. The Public Health Amendment Act 1907 allowed for the enclosure of areas within parks for organised games, the supply of apparatus for such and charging for the use of the apparatus. The Physical Training and Recreation Act 1937 redefined the duties in the Public Health Acts by empowering local authorities to provide and equip playing fields and provide the first open spaces intended purely for the playing of games. The Local Government Act 1972 contained provision for entertainment in parks and The Local Government (Miscellaneous Provisions) Act 1976 conferred general powers to provide recreational facilities.

7. Corporate Plan implications

- 7.1 This Green Space Strategy & Delivery Plan meets the Councils Corporate plan aims to Protect and improve our parks and open spaces for everyone across the borough.
 - Help people to stay healthy be active and feel well.
 - Give children and young people the best start in life and offer them the opportunity to thrive in their communities.

8. Consultation

8.1 The Green Space Strategy and Delivery Plan was open for public consultation for a four week period from 26th June to 24th July via the Council web page, "Have your say" page.

The responses received were overwhelming in support of the strategy and the delivery plan. The results are summarised in the below table showing the percentage of respondents who agree with the strategy themes and delivery plan actions.
