Housing Scrutiny Review

1. Purpose of report

1.1 To provide a high-level overview of housing issues and pressures facing residents and housing services at the council and discuss areas of work that Scrutiny can take forward into a Scrutiny housing Review.

3 Background to the report

- 3.1 Housing services at the council are wide-ranging and each have their own priorities, challenges and opportunities including:
 - Council housing landlord services and repairs, including allocations, tenancy management, responsive repairs, asset management, compliance and regulation.
 - Private sector housing enforcement of conditions in the private sector, Lightbulb, energy efficiency, improvement grants.
 - Strategic and enabling work to maximise affordable housing and take forward housing strategy.

- Homelessness and housing options.
- 3.2 Housing was a priority for many members at the Scrutiny workplan workshop and the following were included in the workplan as possible areas of work:
 - availability of social housing,
 - housing need,
 - council house acquisition / build, homelessness,
 - right to buy
- 3.2 The attached discussion paper provides high-level information on these areas and gives particular emphasis to homelessness in the context of the national and local position, including the reliance on temporary accommodation to meet housing pressures.
- 3.3 Officers have included some suggestions for possible work to be progressed through a Scrutiny Housing Review:
 - Understanding the pathways that people use to access housing and the barriers - this could uncover some of the unknown/unmet lower need.
 - Develop a Strategy to increase the availability of private rented accommodation - carry out further work to understand the private rented sector in Hinckley and Bosworth Borough, including the number of private rented properties, rent levels, demand, and the issues faced by private landlords.
 - Lobby government for more funding for affordable housing, in particular making it easier for councils to increase their own housing stock.
