BOROUGH COUNCIL OF HINCKLEY AND BOSWORTH BOXING DAY MEET, MARKET BOSWORTH (CONTROL OF TRAFFIC) ORDER 2024

This Order is made by Hinckley & Bosworth Borough Council ("the Council") pursuant to powers conferred by Section 21 of the Town Police Clauses Act 1847 for the purpose of regulating the Quorn Hunt Boxing Day Meet ("the event") on Thursday, 26 December 2024 in those areas of Market Bosworth described below between the hours of 10.30am and 12.30pm.

By this Order

- Nothing in this Order shall prevent the use of the road by Police, Fire and Ambulance Emergency Services when responding to an emergency.
- 2. In connection with the event, the following conditions shall be observed:-
 - (a) Any tables, chairs and other obstructions to be used during the event shall be so placed at a safe distance from road junctions and placed as to allow the emergency services to have access to the complete length of the road and area of the closure in the event of the emergency.
 - (b) Organisers should provide a plan for the emergency services which will show the layout during the closure.
 - (c) The organisers shall provide adequate stewarding, using suitably briefed and competent marshals, to be agreed in advance with Leicestershire Police.
 - (d) The organiser shall separate observers and horses where possible.
 - (e) The organiser shall erect metal barriers around the War Memorial.
 - (f) The event shall be adequately signed, such signs to be provided and erected by such organisation(s)/company(ies) as the council's officers shall approve and at the expense of the event organisers. Signs should be exhibited on all roads affected at all their road junctions and traffic prevented from entering the road by physical barriers.
 - (g) Traffic marshals shall have route cards to provide to the public showing an alternative route.
 - (h) A traffic management plan and risk assessment must be produced and approved by Leicestershire County Council as Highways Authority.

- (i) All motor vehicles (except for emergency vehicles) shall be prohibited from entering the area of the road closure whilst the road closure is in force.
- (j) The event organisers must have public liability insurance with a minimum of £5 million of cover and shall indemnify the Council against any incidents occurring at the event.
- (k) The event organisers shall encourage attendees to park vehicles in a considerate manner to alleviate impact on residents.
- (I) The meet be advertised as a meet only and made clear that no hunt will take place.
- 3. The times and roads affected are as follows:-
 - Station Road from the junction with Park Street to the Market Place.
 - Market Place

In the village of Market Bosworth.

- 4. The procession will follow the route below:
 - 10.30am Road closure put in place
 - 10.45am Pedestrians and mounted followers assemble at Market Place
 - 11.00 am Formal meet
 - 11.45am Procession of hounds and mounted followers along Shenton Lane, Warwick Lane, Southfield Way, Haven Road and Weston Drive, calling at Orchard House residential home
 - 12.00pm Hounds and mounted followers progress along Station Road, calling at Bosworth Court residential home
 - 12.15pm Hounds and mounted followers continue along Station Road exiting Market Bosworth via Barton Road
 - 12.30pm Road closure lifted.
- 5. The event shall not deviate from the approved route.
- 6. This Order may be cited as the "Borough Council of Hinckley and Bosworth (Boxing Day Meet, Market Bosworth) (Control of Traffic) Order 2024".
