## JOINT COMMUNITY SAFETY PARTNERSHIP REPORT OF THE MONITORING OFFICER



## WARDS AFFECTED: ALL WARDS

## 1. <u>PURPOSE OF REPORT</u>

- 1.1 To agree an amendment to the Constitution in relation to joint arrangements to support the Joint Blaby and Hinckley & Bosworth Community Safety Partnership and to appoint a Joint Scrutiny Body.
- 2. <u>RECOMMENDATION</u>
- 2.1 Article 9 of the Council's Constitution be amended to include provision for a Joint Community Safety Partnership.
- 2.2 A Joint Community Safety Partnership Overview and Scrutiny Committee be established to operate in line with the attached terms of reference.
- 3. BACKGROUND TO THE REPORT
- 3.1 In April 2011, an informal merger of the Blaby and Hinckley & Bosworth Community Safety Partnerships was implemented with the intention of realising efficiency savings, increasing operational capacity and better outcomes for communities.
- 3.2 Following the success of the informal merger, work began towards a formal merger of the Community Safety Partnerships in the two districts, to be in place before the end of the 2015/16 year.
- 3.3 The implementation of formal joint arrangements requires insertion into the Council's Constitution under Article 9 'Joint Arrangements'.
- 3.4 A key requirement of the formal merger is joint scrutiny of the partnership. The Scrutiny Commission at its meeting on 12 March 2015 considered and endorsed the proposed terms of reference for the 'Joint Community Safety Partnership Overview and Scrutiny Committee'. These now need to be formally agreed by Council along with the necessary inclusion in the Constitution.
- 3.5 Under the joint scrutiny arrangements, the full membership of both authorities' main Overview & Scrutiny bodies will make up the Joint Community Safety Partnership Overview & Scrutiny Committee, and as such will have the same membership as the Scrutiny Commission. The Joint Community Safety Partnership Overview & Scrutiny Committee will meet in autumn each year, with the option to hold additional meetings if necessary. The venue and Chair will alternate.
- 3.6 The Joint Community Safety Partnership Overview & Scrutiny Committee will scrutinise the way the Joint Community Safety Partnership works. This is a different function to the one currently undertaken by HBBC's Scrutiny Commission in its regular review of the Community Safety Partnership in relation to crime reduction and local issues.
- 3.7 Appendix 2 provides some background to the informal merger.

4.1 Any costs will be met from existing budgets.

## 5. <u>LEGAL IMPLICATIONS (JB)</u>

5.1 In order to amend the Constitution this report will require approval of a two-thirds majority of members in attendance.

6.1 This report supports all corporate aims in creating a safer, supportive and vibrant borough and creating efficiency savings by joint working to provide value for money.

## 7. <u>CONSULTATION</u>
