HINCKLEY & BOSWORTH BOROUGH COUNCIL THE DISTRICT OF HINCKLEY & BOSWORTH (OFF-STREET PARKING PLACES) (VARIATION) ORDER 2016

Hinckley & Bosworth Borough Council in exercise of its powers under Section 32 and 35 of the Road Traffic Regulation Act 1984 (as amended) (hereinafter referred to as "the Act of 1984") Schedule 9 to the Act of 1984, the Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") and all other enabling powers and with the consent of Leicestershire County Council in accordance with Section 39 (3) of the Act of 1984 and the Act of 2004 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order.

PART 1: PRELIMINARY

1. Title

This Order may be cited as the District of Hinckley & Bosworth (Off-Street Parking Places) (Variation) Order 2016.

2. Commencement and Effect

This Order shall come into operation on the [] day of [] 2016.

Save as varied by this Order the District of Hinckley & Bosworth (Off Street Parking Places) Order 2014 ("the 2014 Order") will continue to apply.

3. With effect from the [] day of [] 2016 the 2014 Order shall have effect with the following variations.

PART 2: AMENDMENTS

- 4. The Mount Road Car Park included in the 2014 Order is renamed The Leisure Centre Car Park.
- 5. The boundaries of the Leisure Centre Carpark are to be extended as detailed in the plan for the Leisure Centre Carpark in the plan annexed to this Order.
- 6. The addition of two new access roads to the Leisure Centre which are detailed in the plan as annexed to this Order.
- 7. The Leisure Centre Carpark will include Parent and Child Parking Spaces.
- 8. The Jubilee Building (operational depot on Harrowbrook Industrial Estate) plan is removed and replaced with the amended plan for the Jubilee Building (operational depot on Harrowbrook Industrial Estate) detailed in annexed to this Order.
- 9. The boundaries of the Trinity Vicarage Road Car Park are to be extended as detailed in the plan for the Trinity Vicarage Road Car Park as annexed to this Order.
- 10. The following additions are to be made to the Interpretations of the 2014 Order:
 - 1. "NWHC (Harrowbrook Industrial Estate) Permit" means a permit issued by the Council in accordance with the Council's Conditions for Issuing Parking Permits for the time being in force which entitles a vehicle to park in single space at the North Warwickshire and Hinckley College Car Park without displaying a parking ticket.

- 2. "Atkins Long Stay Permit" means a permit issued by the Council in accordance with the Council's Conditions for Issuing Parking Permits for the time being in force which entitles a vehicle to park in a single space at the Atkins Building Car Park without displaying a parking ticket.
- 3. "Residents Permit" means a permit issued to local residents by the Council in accordance with the Council's Conditions for Issuing Parking Permits for the time being in force which entitles a vehicle to park in a single space at the car park as prescribed on the permit only without displaying a parking ticket.
- 4. "HBBC Staff Permit" means a permit issued to Council Staff by the Council in accordance with the Council's Conditions for Issuing Parking Permits for the time being in force which entitles a vehicle to park in a single space at the car park as prescribed on the permit only without displaying a parking ticket.
- 5. "Leisure Centre Staff Permit" means a permit issued by the Leisure Centre Provider on behalf of in accordance with the Council's Conditions for Issuing Parking Permits for the time being in force which entitles a vehicle to park in a single space in the Leisure Centre Car Park without displaying a ticket.
- 6. "Leisure Centre" means the Leisure Centre shown for identification purposes tinted grey on the plan for the Leisure Centre Access Road as annexed to this Order.
- 7. "Parent and Child Parking Spaces" means car parking spaces that are for the exclusive use of the parents when making use of a single parking space in a car park when accompanied by a least one child aged 3 years or younger.
- 8. "Leisure Centre Provider" means the party authorised and responsible for the operation of the day-to-day running of the Leisure Centre.
- 11. The following amendment is to be made to the Interpretations of the 2014 Order:
 - 1. "Leisure Centre Permit" means a permit issued by the Leisure Centre Provider on behalf of in accordance with the Council's Conditions for Issuing Parking Permits for the time being in force which entitles a vehicle to park in the Leisure Centre Car Park for a charge of 50p for 3 hours parking.
- 12. Schedule 1 to the 2014 Order is replaced by Schedule 1 to this Order.

The following amendments have been made to Schedule 1:

- 2. The Charged Hours for all pay and display car parks subject to the 2014 order and this Order are amended.
- 3. The Scale of Charges for Trinity Vicarage Road Car Park is amended.
- 4. The Scale of Charges for Trinity East Car Park is amended.
- 5. The Scale of Charges for the Leisure Centre Car Park is amended.
