(iii) Any employment or business carried on by you;

NOTE:

Give a short description of every employment, office, trade, profession or vocation that you have to declare for income tax purposes, for example "Plasterer" or "Nurse".

(iv) Any person or body who employs or has appointed you;

NOTE:

If you are an employee, you should give the name of your employer. If employed by a company, give the name of the company paying your wages or salary, not that of the ultimate holding company.

Where you hold an office, give the name of the person or body which appointed you. In the case of a public office, this will be the authority which pays you. In the case of a teacher in a maintained school, the local education authority; in the case of an aided school, the school's governing body

(v) Any person or body, other than a relevant authority, who has made a payment to you in respect of your election or any expenses incurred by you in carrying out your duties;

NOTE:

You should declare the name of any person(s) who has/have made any payments to you towards your expenses as a councillor or towards your election expenses. You do not need to declare the amounts of any payments: only the name of the person or body making them.

(vi) Any person or body who has a place of business or land in your authority's area, and in whom you have a beneficial interest in a class of securities of that person or body that exceeds the nominal value of £25,000 or one hundredth of the total issued share capital (whichever is the lower);

NOTE:

1. You do not need to show the actual amount of your interest.

Please note that the nominal value is the value on the face of the security and not its value at the time acquired nor its current market value.

2. If there are several classes of shares or securities, the fraction of 1/100th applies to any of those classes. These limits also apply to deposits with industrial and provident societies, and co-operative societies.

3. The requirement also covers shares and securities held in the name of other people in which you have a beneficial interest.

(vii) Any contract for goods, services or works made between your authority and you or a firm in which you are a partner, a company of which you are a remunerated director, or a person or body of the description specified in paragraph (vi);

NOTE:

You need not say what the financial arrangements are, but should state briefly what the Contract is and for how long.

(viii) The interests of any person from whom you have received a gift or hospitality with an estimated value of at least £25.

NOTE:

Standards Board for England (SBE) Guidance states that "you must register any gifts or hospitality worth £25 or over that you receive in connection with your official duties as a member and the source of that gift or hospitality. The SBE also advises that an accumulation of small gifts received over a short period that add up to £25 or over should also be registered.

(ix) Any land in your authority's area in which you have a beneficial interest;

NOTE:

1. You should include any land in the Parish Council's area in which you have a beneficial interest (that is, in which you have some proprietary interest for your own benefit). You should give the address or a brief description to identify it. If you live in the Parish Council's area you should include your home under this heading as owner, lessee, or tenant.
2. You should also include any property from which you receive rent, or of which you are the mortgagee.
3. "Land" includes any buildings or parts of buildings.
4. When the information to be recorded relates to a house or flat, this does not present any difficulty in providing an address. However, the registration of other land interests such as farm land, or other land with no address, is not as easy. In these circumstances you should include enough information with this form so that landholdings can be identified (eg. a map).
